Policies

A SIGNED CONTRACT IS REQUIRED A MINIMUM OF 60 DAYS PRIOR OF THE WEDDING DATE TO SECURE THE DAY.

IF YOU MUST CANCEL, A CANCELLATION MAY BE TAKEN NO LATER THAN 45 DAYS PRIOR TO THE WEDDING DATE. IN THE EVENT OF A CANCELLATION WITHOUT A 45 DAY'S NOTICE, THE BRIDE/BRIDAL PARTY IS RESPONSIBLE FOR THE TOTAL AMOUNT OF SERVICES LISTED ON THE SIGN CONTRACT.

IN THE EVENT A BRIDAL PARTY MEMBER IS TARDY, THE REQUESTED STYLE MAY BE ALTERED TO ACCOMMODATE THE TIME FRAME.

Wedding Day Logistics

BRIDAL PARTY MUST BE PRESENT & ON TIME. WE REQUIRE ALL HAIR TO BE CLEAN AND DRY BEFORE START TIME. BUTTON DOWNS, ZIPPERED OR ROBES ARE RECOMMENDED TO ENSURE HAIR STAYS INTACT WHILE CHANGING.

Payment

PLEASE DO NOT FILL OUT THIS SECTION. SALON WILL DO SO ONCE DETAILS ARE SUBMITTED AND PAYMENTS ARE RECEIVED.

A NON-REFUNDABLE DEPOSIT IS REQUIRED TO HOLD THE WEDDING DATE. 25% OF THE TOTAL BILL MUST BE PAID 60 DAYS PRIOR TO THE WEDDING DATE.
