Wedding Day Logistics

We will provide a schedule for our stylist(s) based on the start & finish time. Depending on the amount of people serviced, the start time may need to be adjusted. We will communicate this. If you are working with a make up artist, we will reach out to them.

Bridal party must be present & on time. We require all hair to be clean and dry before start time.
Button downs, zippered tops/dresses or robes are recommended to ensure hair stays intact while changing.

In the event a bridal party member is tardy, the requested style may be altered to accommodate the time frame.



Terms & Conditions

A signed contract is required a minimum of 60 days prior of the wedding date to secure the day (booking). If it is within 60 days of the wedding date, depending on the time of booking, payments may be required.

If you must cancel, a cancellation may be taken no later than 45 days prior to the wedding date and the Initial Payment (Deposit) will be kept. Cancellation must be made in writing, signed by the Bride(s), and sent via email greyrosesalonpgh@gmail.com. In the event of a cancellation without a 45 day's notice, the Bride is responsible for the total amount of services listed on the sign contract. If the payment isn't received the day of the cancellation, the card on file will be charged accordingly the following day.

Everyone getting serviced must be finalized 30 days prior to wedding date. If cancellations or changes within 30 days of the wedding date results in a monetary loss for Grey Rose Salon LLC and its employees, the Bride will be required to cover that discrepancy.

If additional people are added after the final payment (see below when final payment is due) is received and we are able to accommodate them, each additional person will be \$125 due no later than the wedding date. If the payment is not received on time, the card on file will be charged accordingly.

In the event, Grey Rose Salon LLC cannot or will not perform its obligations under this Contract, we will: 1. Immediately give Notice to Bride; 2. Attempt to find another competent professional to take its place with the mutual agreement of the Bride; 3. If another competent professional is not available or the Bride does not agree to transfer of obligations to said alternate professional, Grey Rose Salon LLC will issue a refund or credit based on a reasonably accurate percentage of services rendered; and 4. Excuse Clients of any further performance and/or payment obligations in this Contract. (Please note, this has never happened)

I acknowledge and agree that it is my responsibility to inform all members of the bridal party, serviced individuals, and any persons present in the room of this liability release and to obtain any necessary consent on their behalf.
